CONSIGNMENT RATES:

20% : ALL GENERAL MERCHANDISE (RETAIL and WHOLESALE LOTS)

*ANTIQUES, COINS, COLLECTIBLES (see below), FURNITURE, RUGS, TOOLS, HARDWARE, GENERAL EQUIPMENT, BUILDING SUPPLIES, APPLIANCES, HANDBAGS ETC. (basically all merchandise except below)

15% : ALL VEHICLES, MAJOR FARM & BUILDING EQUIPMENT (like commercial tractors, bull dozers etc.) – *ANTIQUES, INDIVIDUAL COINS, and COLLECTIBLES VALUED AT OVER \$5000.00 per and LIVESTOCK

5% : PROPERTY / LAND / RENTALS & LEASES

30% : for all BOX LOTS

NO BUYERS PREMIUM will be charged to those renting space @ The Big TARP flea market

10% buyers premium will be charged on all other purchases

ALL purchases made at auction, or items that did not sell, must be picked up and removed completely from the Big TARP no later then the
(((**FRIDAY 3pm**))) after auction

HERE ARE SOME BASIC RULES & GUIDELINES:

1. No items are to be unloaded until consignment has been approved by The Big TARP Auction staff, and consignment agreement signed by consignee. Management will decide how and the order by which all items / lots / consignments will be sold. A \$50 fee will be charged for items / lots / consignments removed from auction area after consignment agreement is completed, before auction takes place.
2. All appliances & electronics must be demonstrated to be in working condition before they can be sold. No broken or heavily damaged appliance or electronics will be accepted.
3. a \$25 fee will be charged for consignments left to be set up, or displayed by The Big TARP staff (we are happy to HELP, but if we are left to do it alone, we must charge for our time)
4. The Big TARP Absolute Auction center will NOT ACCEPT leftover yard sale items - in an effort to maintain a certain level of quality we will avoid lots or items that appear to fit into this category – if it didn’t sell sittin’ on your lawn, it probably isn’t worth selling at the auction (thanks!)
5. Consigners of new merchandise – Please DO NOT flood the auction with an overabundance of any one item – we will sell the item once, and it will be passed out for whatever it brings (also NO DAMAGED merchandise please!)
6. We do not accept used clothing unless it is deemed “VINTAGE” – also NO hazardous materials, semi full paint, paraphernalia, drugs, guns, old tires, or used medical items will be accepted at the auction.
7. All items NOT SOLD must be removed from premises no later than the Friday preceding the auction – Consignees with items not sold / not picked up will be charged a \$50 dumping fee which must be paid in full before any other consignments are accepted. Items not sold can not be brought back to the auction without previous consent.
